Event privacy regulation:

"MEETING OF THE 40 YEARS OF THE HISTORICAL REGISTER VESPA"

Pursuant to and for the purposes of art. 13 of the European Regulation n. 2016/679 (hereinafter the "Regulation"), we provide you with the following information relating to the processing of personal data that you give us in relation to the registration and participation in the 40-year meeting of the HISTORICAL VESPA REGISTER.

1. Data controller

The data controller is Vespa Club Rovereto (Tax Code 94006710225) with registered office in Rovereto, Piazza S. Osvaldo, 4 tel 3389384165, e-mail address rovereto@vespaclubditalia.it hereafter Vespa Club Rovereto, in the physical person of the President pro tempore.

2. Personal data

By personal data we mean any information that concerns you and is referable to you. Specifically, the processing may concern the following data: name, surname, Club to which it belongs, role in the organization, address, municipality, province, nationality, telephone numbers and e-mail address, plate and chassis of the vehicles owned, hereinafter "data".

3. Purpose of the treatment

Your data will be processed for the following purposes:

- 1. registration and participation in the "40 years of the Vespa Historical Register" event;
- 2. sending of material relating to the event;
- 3. creation and dissemination of audio, video and photographic footage related to the event;
- 4. Legal basis of the processing

The processing of your data for the purposes indicated in the previous point 3) has a legal basis in the consent you have expressed.

5. Processing methods

As part of the purposes indicated in point 3) above, the processing of your data will take place in paper form and by electronic means, in compliance with the regulatory provisions on the processing of personal data, adopting the appropriate security measures.

The processing of your data will be managed by personnel specially trained and instructed by the Vespa Club Rovereto in the person of the President pro tempore, precisely to guarantee adequate security and confidentiality, as well as to avoid risks of loss and / or destruction and access by subjects unauthorized.

6. Communication and dissemination of data

Within the limits strictly pertinent to the purposes indicated in the previous point 3), your data may be communicated to subjects specifically authorized by the Vespa Club of Italy.

The audio, video and photographic recordings made on the occasion of the event depicting your person, can be published, simultaneously and / or after the event itself, on the web, on social networks, in newspapers or periodicals, on brochures and audio / video supports for information and promotional purposes of Vespa activities only.

7. Data retention period

Your data will be kept for a period of 1 year from the date they are collected, without prejudice to the possibility of revoking consent.

8. Rights of the interested party

With reference to your data, you have the right to ask Vespa Club Rovereto, in the manner indicated in the Regulations:

- access, in the cases provided;
- the correction of incorrect data and the integration of incomplete data;
- the cancellation of the Data for the reasons provided, such as when they are no longer necessary with respect to the purposes indicated above or are not processed in compliance with the Regulations;
- the limitation of treatment for the hypotheses provided, as in the case of the accuracy of the Data and it is necessary to verify its correctness;

Portability, that is, the right to receive and transmit, in the cases provided, said Data to another data controller;

• opposition to treatment, in the cases provided.

You also have the right to withdraw consent at any time without prejudice to the legality of the treatment given before the revocation.

9. Complaint

If you believe that the processing of your data violates the provisions contained in the Regulation, you have the right to lodge a complaint with the Guarantor for the protection of personal data in accordance with the provisions of art. 77 of the Regulation itself.

10. Nature of the provision of data

The provision of your data is optional, but a necessary requirement for participation in the event, failure to provide said data implies the objective impossibility of participating.

The refusal to create and disseminate audio, video and photographic footage made on the occasion of the event, depicting your person, could make it impossible to participate in the event itself.
